Earlier I reported to you that UTRA was trying to work with the administration on two issues that would be of interest and benefit our members: 1) to have a room in the new University Center designated as one where retirees could come and relax, converse, and/or store some things we wouldn't want to carry around while on campus, and 2) to increase the number of parking spaces for the handicapped.

On the University Center issue, a representative of Chancellor Cheek has been made aware of our request, has responded to our request, and has said that she will investigate the possibility of such a room. We will keep in contact with her on a regular basis as construction goes forward.

On the parking issue (thanks to Henry Fribourg), I have been in touch with the vice chancellor responsible for parking and will meet with him in the near future. Also, we have decided to join forces with the Student Committee on Disability Issues to press the matter. Since some of us were in college in the 1960s, I thought it best to promise that we had no intention of picketing Andy Holt Tower or engaging in other 1960s behavior. (Henry refused to promise that). This past semester, the student organization held a very well-attended Disabilities Week, to make the campus aware of important necessities. The student organization will hold its first spring meeting in mid-February, and we will get together after that. Thanks to Henry for providing the names of other UTRA members who might help out.

Finally, elsewhere in this newsletter is a piece on a Life Planning Seminar on Long Term Care. In my view, this is something well worth knowing about.

Later, he worked as Director of Advancement for the International Storytelling Center in Jonesborough, TN.

LTC-TN, the State of Tennessee Group Long-Term Care Insurance Program offered through MedAmerica Insurance Company, is available to UT retirees who are drawing a Tennessee Consolidated Retirement System (TCRS) benefit or participate in an optional retirement plan.

The State of Tennessee Department of Commerce and Insurance has certified LTC-TN as a Tennessee Long-Term Care Partnership policy. This means if you buy the appropriate "inflation benefit" for your age, you can protect assets equal to the benefits paid out if you ever have to apply for Medicaid/TennCare to pay for long-term care services.
