Optional Materials

The nominee may also submit the following optional (testimonial) materials:

- Oualitative evaluation comments from students; and/or
- Notes/emails from current and former students who were enrolled in the nominee's classes during the year in consideration. These should not be solicited to support the nomination but rather written previously and voluntarily by students.

The Graduate Studies committee will review submitted materials in late March and notify the Dean of their decision.

Required Materials

Individuals who wish to pursue this award must submit the following required materials via email by March 10th:

- A research philosophy;
- The nominee's best "piece" of research or creative activity (as selected by the nominee) from the two previous calendar years (research must have been published, presented, or in-press during 2012 or 2013). Research "pieces" include, but are not limited to, refereed journal articles; refereed conference proceedings; refereed books or book chapters; examples of juried or other refereed creative works; refereed monographs; non-refereed journal articles; non-refereed conference proceedings; non-refereed books or book chapters; non-refereed monographs; examples of other creative works; and
- A current vita.

The nominee may also submit the following <u>optional</u> (testimonial) materials: Anything that has been published about the submission (e.g., reviews, award nominations, etc.).

The Graduate Studies committee will review submitted materials in late March and notify the Dean of their decision.
