The University of Tennessee Institute of Agriculture (UTIA) Marketing and Communications office seeks to hire a creative and highly motivated graphic designer to join its team. This position works closely with other team members and clients to support the mission and uphold the brand of UTIA and its units and departments. This person will design and/or update various printed and electronic materials that will represent UTIA visually to constituents within the organization, throughout the state of Tennessee, and globally. This position requires the ability to create original designs with a high visual impact and that adhere to the existing UTIA brand guidelines. Projects may range from small-scale updates of existing designs to larger-scale items such as annual reports or magazines. This person should have a good understanding of how design relates to emerging technologies and social media. On occasion, this position may also have photography duties.

Required

- Bachelor's degree in Graphic Design or Communication Graphics Technology; or associate's degree in Graphic Design or Communication Graphics Technology with two years of professional graphic design experience.
- Strong design skills to include composition, typography, color, and photography
- Advanced proficiency in current version of the Adobe CS software

- Ability to multitask and prioritize jobs
- Work well independently as well as within a group
- Be receptive to constructive criticism
- Professional and customer service-oriented attitude
