WE ARE RECRUITING TO FILL A PERMANENT, FULL-TIME FOREST INVENTORY & ANALYSIS FIELD FORESTER POSITION TO WORK WITH OTHER FIA CREWMEMBERS COLLECTING STATEWIDE FOREST DATA.

<u>Major Duties</u>: FIA consists of an extensive inventory of the forestlands, woodlands, and associated rangelands across the state using a network of permanent research plots. Data collection is performed by highly trained, two-person crews that visit each research plot and record measurements using standard national and regional protocols and procedures. The entire inventory effort follows strict program standards to meet the yearly planned objectives—data collection on 10-20% of all plots each year. The FIA Field Forester is generally responsible for carrying out the duties described below in cooperation with agency personnel, other state and federal agencies, private landowners, and program cooperators. Responsibilities include:

- becoming fully trained and certified in FIA data collection procedures and program policies (on the job training with USFS FIA personnel)
- becoming thoroughly familiar with FIA program policies following data collection procedures outlined in FIA Field Manual
- interpreting aerial photographs, using GPS technology, and maps to find plot locations
- utilizing forestry measurement tools, hand-held computers, etc., to collect data accurately
- planning wisely to transmit data promptly and meet productivity targets
- cooperating with and participating in other programs within Oklahoma Forestry Services



Education and Experience: Requirements at this level consist of a bachelor's degree in forestry from an accredited university. Other important attributes include good problem-solving skills, oral and written communication skills, ability to plan, computer skills, the ability to develop effective working relationships with a variety of people, ability to think independently and exercise good judgement.

<u>Physical Demands & Work Environment</u>: The position is primarily responsible for conducting forest inventory on assigned plots in the southern half of the state. This position is physically demanding. The majority of work is performed outdoors, often in rough terrain, with dense briars and underbrush, in hot or cold, wet, windy, or otherwise inclement weather. Vehicular travel throughout the state and hiking to individual plot locations are a considerable aspect of the job. In rare instances, FIA duties may require swimming or wading in order to reach sites to obtain resource data when boat or other access is not available.

<u>Travel or Special Requirements</u>: A valid Oklahoma driver's license is an important job requirement, and frequent travel is an obligation of this position. Although activities focus on the southern counties, plot work and travel statewide is necessary in support of other FIA personnel and for training. An average of **70% of the year** may be spent in travel

status where it is more efficient to stay overnight rather than to return home or the base station. The FIA employee may also attend OFS meetings, and other FIA training opportunities that require overnight in-state or out-of-state lodging.

The employee must complete a structured training program and become certified in FIA plot measurement procedures within 5 months of employment or as soon as practical, based upon the federal training schedule. The FIA employee must maintain an accuracy rating on all plots in order to maintain FIA certification after completion of the training period.

Degrees in natural resources or NREM degrees sometimes get kicked out as not qualified, so be sure to indicate your degree is in forestry or you have a forestry emphasis.
