A message from the Provost

I'm pleased to introduce you to the university's new accreditation newsletter, "In Compliance."

We are preparing for the 2025 reaffirmation of our accreditation status with the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC). Institutional accreditation is a recognized mark of quality that certifies the value of the university's coursework and degrees, both to other institutions of higher education and to external stakeholders. We must remain accredited to offer our students federal financial aid, and accreditation allows our students to transfer coursework to other institutions.

The reaffirmation process challenges us to perform a detailed self-study that examines every aspect of what we do. The self-study process helps us demonstrate that we are effective in meeting accreditation standards that represent shared values and practices. While this examination takes time and effort, the result is well worth it.

This critically important work is a university-wide effort. Please stay informed by reviewing future editions of this newsletter. I also hope that you will answer the call to serve, as you are able, on faculty and staff committees that will be instrumental in a successful reaffirmation.

Making a CIP Code Change?

Effective March 2022, each request (i.e., each program) must be submitted on a standard form, which includes an explanation of the curriculum and justification for the change in the code based on an alignment between the program of study, institutional academic program, and the federal CIP. All CIP code changes must be approved by the institution and by the Tennessee Higher Education Commission (THEC).

Following the prescribed steps will ensure that the codes in Banner that are used for reporting purposes and the institution's official listing of CIP codes, which is shared with institutional accreditor Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), are current.

Reaffirmation Report Timeline

Preparations have begun for the 2025 Reaffirmation process by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC). To address the Principles of Accreditation (standards), the university's SACSCOC Liaison, Dr. Heather Hartman is holding meetings with key stakeholders across campus to address the Principles of Accreditation (standards) and to develop the new Quality Enhancement Plan (QEP).

Representatives from across campus will be asked to participate in planning, developing, and writing the QEP, as well as the narratives that will communicate how the university meets various Standards through implemented policies and procedures. Below, you will see an abbreviated timeline for completing tasks toward the goal of submitting the Reaffirmation Report and QEP, followed by a campus visit.
