Position Description:

The White River National Forest soon hopes to fill two permanent GIS Specialist positions in the Renewable Resources and Planning Program located at the Supervisor's Office in Glenwood Springs, Colorado. However, until that vacancy is open, we are looking for individuals interested in a NTE 120 Days Temporary Promotion. The Renewable Resources GIS Specialists provide geospatial guidance, leadership, and integrated support for product and spatial data management. The purpose of this outreach is to assess the interest in both the permanent position and the detailing promotional opportunities. Direct hire may be utilized using special hiring authorities such as Veterans Preference, Schedule A, Military Spouses, Peace Corps, and former USFS Resource Assistant Program Participants with a Direct Hire Authority certificate.

What we are looking for in a Candidate:

The Renewable Resources and Planning Program is looking for the following in the candidates:

- Provides leadership in the development and use of spatial data and advanced geospatial technological applications and serves as principal technical advisor on Geographic Information Systems (GIS).
- Highly proficient in utilizing ArcGIS Pro and assist forest staff with the upcoming agency transition to ArcGIS Pro from ArcMap.
- Develops and implements geospatial program goals in conjunction with resource management objectives and organizational business requirements.
- Develops data dictionaries, data models, and metadata for multi-disciplinary information and geospatial applications.
- Coordinates conversion of geospatial information and remote sensing imagery into GIS databases.
- Responsible for organization and maintenance of resource information and data to facilitate analysis
 across multiple disciplines such as timber, fuels, botany, wildlife, fisheries, range, geology, soils,
 hydrology, and planning.
- Coordinates input from managers and resource specialists to determine type, amount and level of

- information required to develop and analyze ecosystem management alternatives.
- Assesses quality, compatibility, and limitations of various data used in a wide array of land management and planning efforts.
- Manipulates and analyzes geospatial data to support resource management decisions for multiple resource, jurisdictional, and ownership units or a large geographical region.
- Performs multi-scale and/or multi-resource analysis in support of planning, analysis, and monitoring activities.
- Manage competing requests for geospatial analytical support and map production on various on-going forest-wide NEPA projects and occasional time sensitive requests from the Regional and/or Washington Offices.
- Knowledge or willingness to learn of the USFS Natural Resource Manager (NRM) databases.
- Have strong technical skills in ArcGIS Online and Esri mobile applications that can assist specialists with setting up Field Maps and Survey123.
- Conducts formal and informal training and provides technical assistance to GIS software users in the development, storage, retrieval and analysis of data.
- Serves as technical point of contact and maintains liaison with the Regional Office (RO), Federal, State, and local governments; learning institutions; the private sector; professional organizations; and other individuals concerned with GIS, GPS, remote sensing and mapping.

This is a challenging position with a wide variety of tasks to be accomplished. To be successful in this position, you must be a self-starter, thrive in a fast-paced environment, and be willing to take on challenges and provide innovative solutions to complex problems. The ability to lead, communicate, manage complex projects; and be a collaborative team member are all vital skills for this position.

About the White River National Forest:

The White River National Forest is 2.3 million acres in central Colorado. The Supervisor's Office is located in Glenwood Springs with District offices in Meeker, Rifle, Carbondale, Aspen, Eagle, Minturn, and Silverthorne.

Currently, the White River employs approximately 140 permanent employees and 100 temporary employees. The White River National Forest is one of the crown jewels of the National Forest System. It hosts nearly 13 million visitors per year. With 12 ski resorts, the White River is the premier place for winter recreation and is a destination for people from around the globe.
